Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities and Ozark International, Inc. have filed a joint application asking the Commission to authorize Liberty Utilities to acquire the franchise and operating assets of six water and sewer companies that are wholly-owned subsidiaries of Ozark International. The established procedural schedule set an evidentiary hearing for March 22 and required the parties to make other filings before the hearing. On March 16, the parties filed a unanimous stipulation and agreement to resolve all outstanding issues. On March 19, the Joint Applicants filed a motion requesting that the hearing and the remaining procedural schedule be canceled.

The Commission will grant that motion.

THE COMMISSION ORDERS THAT:

1. The remaining procedural schedule, including the hearing scheduled for March 22, 2018, is canceled.

2. This order shall be effective when issued.
