

ORDER APPROVING TARIFFS

On April 15, 2019, Confluence Rivers Utility Operating Company, Inc. ("Company") filed proposed tariff sheets YW-2019-0182,¹ YS-2019-0183,² YW-2019-0184,³ and YS-2019-0185.⁴ These tariff sheets were filed in response to the Commission's February 14, 2019 Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity ("Order"). This Order required the Company to adopt the existing sewer and water tariffs currently in effect for Gladlo Water & Sewer Company, Inc., Calvey Brook Water, Inc., and Calvey Brook Sewer, Inc. The tariff sheets are proposed to become effective on May 15, 2019. The Company also filed substitute tariffs on April 24, 2019.

Staff filed a Recommendation on April 26, 2019. The Recommendation stated that the tariffs as substituted comply with the Commission's Order, and recommended that the

4. The tariff sheets in Tariff No. YS-2019-0185, issued April 15, 2019, as substituted on April 24, 2019, are hereby approved to become effective on May 15, 2019.

5. This order shall be effective on May 15, 2019.
