STAFF'S COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby submits this *Staff's Compliance Tariff Recommendation*.

- 1. On September 20, 2018, the Commission issued its *Order Approving Transfer of Assets and Granting Certificates of Convenience and Necessity (Order)*. The *Order* directed Missouri-American Water Company (MAWC), among other things, to submit new tariff sheets in compliance with the *Order* prior to closing on the assets.
 - 2. On November 8, 2018, MAWC filed the new tariff sheets.
- 3. On November 9, 2018, the Commission directed Staff to file a recommendation regarding Tariff File Nos. YW-2019-0087 and YS-2019-0088, and gave a deadline of November 16, 2018.
- 4. On November 15, 2018, MAWC filed a substitute tariff sheet to correct the service area legal description on Original Sheet CA 19.2.
- 5. After review, Staff concludes that the filings comply with the Commission's Order. Thus, Staff recommends approval of:
