

Applicant Lake Lorraine Property Owners' Association files this final report with the Commission, concerning the termination of Frimel Water System, Inc. and the distribution of its assets:


1. The Department of Revenue has issued its Tax Clearance letter and same has been filed with the Secretary of State.

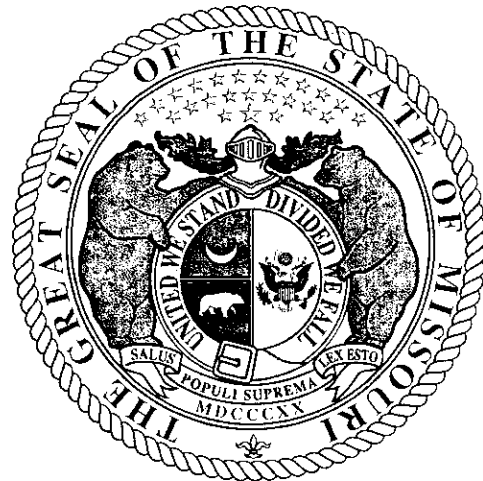


