**SUPPLEMENT TO JOINT APPLICATION**

Pursuant to an Order issued on September 11, 2003, Warren County Water & Sewer Company, Warren-Lincoln Investments, Inc., d/b/a Warren County Water & Sewer, and Gary Smith and A. Lynn Smith ("Warren County") were directed to supplement the joint application with additional information and specific details of the Circuit Court proceedings pending in Warren County Missouri.. Warren County submits the following in response to the Commission's directive;


On or about October 30, 2003, the Commission filed a Petition for Appointment of Receiver for Warren County Water & Sewer Company in Warren County Circuit Court. On or about May 12, 2003, Warren County advised the Court that it had accepted, subject to Commission approval, the offer of Missouri American Water Company to acquire all of it's public utility assets. On May 13, 2003 the Court entered a Memorandum that states; "Case comes on for trial. Defendant Water & Sewer Company consents to judgment and appointment of a receiver, effective in 90 days. If a petition for transfer of ownership of Water & Sewer Company if (sic) filed, but not completed, before the Missouri Public Service Commission at the end of the 90 day period, the judgment may be continued by the consent of the parties."

To date there has been no further activity in the pending matter in Warren County Circuit Court.

Wherefore, Warren County submits this Supplement to the Joint Application in compliance with the Commission's September 11, 2003 Order.
