**ORDER DIRECTING NOTICE AND ADDING**  
**PUBLIC WATER SUPPLY DISTRICT NO. 2 OF**  
**TANEY COUNTY, MISSOURI AS A PARTY**

On June 30, 2006, White River Valley Water Company filed an application with the Commission requesting authority to sell its sewer/treatment facility to the Public Water Supply District No. 2 of Taney County, Missouri (the Water District). White River is a small privately owned water utility company subject to the jurisdiction of the Public Service Commission and located in Forsyth, Missouri.

The Water District is not subject to regulation by the Commission and did not join in the application. The Water District's presence as a party is necessary for a full consideration of White River's application. Therefore, the Water District will be added as a party to this case.

Proper parties should be given notice and an opportunity to intervene in this matter. The Data Center of the Commission shall send a copy of this order to the County Commission of Taney County, Missouri, and to the Missouri Department of Natural Resources. The Information Officer of the Commission shall make notice of this application

available to the members of the General Assembly who represent Taney County, and to the media that serve Taney County.

Proper persons wishing to intervene shall file an application to intervene with the Secretary of the Missouri Public Service Commission. Copies of the application to intervene should be sent to the parties listed below.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary and that White River may submit its evidence in support of the application by verified statement.<sup>1</sup>

**IT IS ORDERED THAT:**

1. The Public Water Supply District No. 2 of Taney County, Missouri, is made a party to this case.
2. The Information Office and the Data Center of the Missouri Public Service Commission shall provide notice as set out herein.
3. Any interested person wishing to request a hearing or intervene in this case shall file a request or an application on or before July 24, 2006 with:
