1. On April 11, 2012, Moore Bend Water Company, Inc. (Moore Bend) and Moore Bend Water Utility, LLC (MBU) filed a Joint Application with the Missouri Public Service Commission (Commission) requesting authority for Moore Bend to sell certain assets to MBU.

On August 14, 2012, Public Counsel requested that the Commission schedule an 2. evidentiary hearing in this matter to determine if the transfer is in the public interest.

3. On January 25, 2013, the Commission directed the parties to file a list of disputed facts no later than February 6, 2013. The Commission stated that Public Counsel is to be responsible for this filing.

Public Counsel now states that it has been informed by the Staff Counsel's Office that 4. more time is necessary to prepare the list of disputed facts ordered by the Commission.
