On September 14, 2017, Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities and Ozark International, Inc. filed a joint application asking the Commission to authorize Liberty Utilities to acquire the franchise and operating assets of six water and sewer companies that are wholly-owned subsidiaries of Ozark International. The Commission issued notice of the filing of that application and directed that any application to intervene be filed by October 6. A timely application to intervene filed by the Missouri Department of Natural Resources has been granted. No other applications to intervene have been filed.

The Commission would like to move this matter to resolution. To do that, the Commission will direct the parties to file a proposed procedural schedule. If the parties believe this application can best be resolved through the filing of a Staff recommendation, they may propose that procedure. If they believe testimony and other

evidentiary hearing procedures are necessary, they may propose a schedule to accomplish that purpose.

THE COMMISSION ORDERS THAT:

- 1. The parties shall file a proposed procedural schedule no later than October 24, 2017.
 - 2. This order shall be effective when issued.
