On March 15, 2022,¹ Foxfire Utility Company (Foxfire) filed an application seeking Commission authority to sell its water and sewer assets to Ozark Clean Water Company. It also asked to be relieved of its responsibilities as a water and sewer corporation and cancelation of its certificates of convenience and necessity and tariff sheet. On April 8, Staff filed a Status Report proposing to submit its recommendation by June 14, and on June 14, Staff filed a motion for an additional 14 days to file its recommendation.

The Commission will direct the Commission's Staff to file a recommendation no later than June 28.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation in this matter no later than June 28, 2022.
2. This order shall be effective when issued.
