**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Staff Recommendation for Adoption Notice Tariff Sheets* hereby states:

1. On September 14, 2020, Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities (“Liberty Utilities”) submitted multiple adoption notice tariff sheets to be effective October 16, 2020. On September 17, 2020, the Commission ordered Staff to file a recommendation regarding the tariff sheets.

2. Staff has reviewed the adoption notice tariff sheets and finds them to be in compliance with Commission Rule 20 CSR 4240-2.060(5)(C). Thus, Staff recommends the Commission approve the adoption notice tariff sheets filed on September 14, 2020.
