
Please find enclosed for filing in the above-referenced Case No. TT-2006-0113 the Stipulation executed this date by Socket Telecom, LLC, Spectra Communications Group, LLC ("Spectra"), CenturyTel of Missouri, LLC ("CenturyTel") and the Staff of the Missouri Public Service Commission. As reflected in the document, the Stipulation was entered into by these parties to resolve disputes associated with this proceeding.
