### ORDER DIRECTING NOTICE AND ORDER DIRECTING FILING

On October 24, 2017, Missouri-American Water Company and Spokane Highlands Water Company ("Applicants") filed a joint application with the Missouri Public Service Commission ("Commission") seeking authority for Missouri-American Water Company to purchase substantially all of the water assets of Spokane Highlands Water Company. Applicants also request certificates of convenience and necessity for Missouri-American Water Company and waivers from certain Commission administrative rules.

Section 393.190.1, RSMo 2016, requires that when transactions such as the one described in the application are submitted to the Commission for approval, the Commission must send notice "to the county clerk of each county in which any portion of a political subdivision which will be affected by such disposition is located." Since the application states that the water facilities being sold are located in Christian County, the Commission will direct its Data Center to send a copy of this order to the county clerk

and county commission of Christian County, Missouri. The Commission will also establish deadlines for persons wishing to intervene and a preliminary response from its Staff.

### THE COMMISSION ORDERS THAT:

- 1. The Commission's Data Center shall send a copy of this order to the county clerk and county commission of Christian County, Missouri.
- 2. Any interested person wishing to intervene in this case shall file an application to intervene no later than November 21, 2017.
- 3. No later than November 21, 2017, the Staff of the Missouri Public Service Commission shall file a pleading stating when it anticipates filing its recommendation in this matter.
  - 4. This order shall be effective when issued.
