**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), through counsel, and recommends that the Commission approve the proposed substitute tariff adoption notice Liberty Utilities LLC (Missouri Water) ("Liberty Utilities") filed July 12, 2020, bearing an effective date of August 8, 2020.

1. The Commission issued its Order Approving Transfers of Assets and Granting Certificate of Convenience and Necessity ("Order") on May 8, 2020. Liberty Utilities filed a proposed tariff adoption notice on July 9, 2020 and a substitute proposed tariff adoption notice, which includes a proposed title page, on July 12, 2020, both bearing effective dates of August 8, 2020.

2. On July 10, 2020 the Commission ordered Staff to review Liberty Utilities' proposed tariff adoption notice and file a recommendation by July 20, 2020.

3. Staff reviewed the substitute proposed tariff adoption notice and proposed title page and determined that they are in compliance with the Commission's Order, and Staff recommends approval. Staff attaches an affidavit with this pleading verifying its review.

WHEREFORE, Staff recommends that the Commission approve Liberty Utilities' substitute proposed tariff adoption notice filed July 12, 2020, bearing an effective date of August 8, 2020.
