The accompanying tariff sheets issued by Union Electric Company d/b/a AmerenUE (AmerenUE or the Company), are being transmitted to you for filing as a revision of Schedule No. 2, Schedule of Rates for Gas Service:

These tariff sheets are being issued March 17, 2009 to become effective on and after April 1, 2009.

These revised sheets include changes to Company's Purchased Gas Adjustment (PGA) Clause as approved by the Commission. They reflect adjustments to the Regular Purchased Gas Adjustment (RPGA) factors for the Company's four Missouri service areas.


The changes in the PGA factors applicable to the Company's service areas, excluding the Rolla area, result from a decrease in the weighted average cost of gas. The firm sales customers' PGA factors will decrease from 99.50¢/Ccf to 75.00¢/Ccf. The interruptible sales customers' PGA factors will decrease from 83.03¢/Ccf to 58.02¢/Ccf. The transportation PGA factor will remain unchanged at 0.00¢/Ccf.

The changes in the PGA factors applicable to the Company's Rolla service area (formerly Aquila's Eastern System) result from a decrease in the weighted average cost of gas. The firm sales customers' PGA factor will decrease from 121.42¢/Ccf to 95.00¢/Ccf. The interruptible sales customers' PGA factor will decrease from 84.28¢/Ccf to 59.27¢/Ccf. The transportation PGA factor will remain unchanged at 0.00¢/Ccf.



We are enclosing workpapers supporting this filing with the copy of this filing being provided to the Staff. Certain of the work papers have been designated "Highly Confidential" since they contain market specific information directly relating to the natural gas markets where AmerenUE must compete for its gas supplies. AmerenUE requests that these papers be handled in a manner consistent with this designation.
