**ORDER GRANTING MOTION TO FILE OUT OF TIME**  
**AND CLOSING CASE**

Issue Date: February 28, 2007

Effective Date: March 10, 2007

On January 10, 2006, the Commission issued an order approving a Stipulation and Agreement in this case in which the parties agreed, among other things, that the Greenwood exchange would become a mandatory Metropolitan Calling Area (MCA) Plan exchange in the Kansas City MCA. Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri, subsequently filed its compliance tariff, which was approved for service on and after June 29, 2006. The order also directed that after the tariff sheets had become effective and until January 1, 2010, AT&T Missouri shall file a notice in this case if it increases the MCA rates for the Greenwood exchange. The notice is to be filed within two weeks of the effective date of the increase.

On February 13, 2007, AT&T Missouri filed a Notice and Motion to Accept Out of Time. Therein, AT&T Missouri notified the Commission that business service rates in the Greenwood exchange increased by one dollar as part of the rate increase for business service (flat-rate one-party, flat-rate trunk, and multiline trunk) in all competitive classified exchanges. The increase became effective January 1, 2007. AT&T Missouri stated that its

failure to timely provide the notice was inadvertent, and requested that the Commission accept the notice out of time. No response to the motion was received.

The Commission has reviewed AT&T Missouri's notice and motion, and finds that no harm has accrued to any party or the public by AT&T Missouri's failure to file the notice in a timely fashion. The Motion to Accept Out of Time is granted.

As no further action is needed at this time, the Commission will close this case.

**IT IS ORDERED THAT:**

1. Southwestern Bell Telephone, L.P., d/b/a AT&T Missouri's Motion to Accept Out of Time is granted, and the notice filed February 13, 2007, is accepted.
2. This order shall become effective on March 10, 2007.
3. This case may be closed on March 11, 2007.
