## FIRST QUARTER 2004 STATUS REPORT OF WORLDCOM, INC., AND ITS U.S. SUBSIDIARIES

As its March 2004 quarterly report, WorldCom, Inc., now known as MCI, is pleased to advise that the U.S. Bankruptcy Court has granted MCI's request for a 60-day extension to formally emerge from Chapter 11 bankruptcy. MCI informed the Commission of the request for the extension necessary to complete its filings with the Securities and Exchange Commission via its February 12, 2004 letter. Also of note, MCI and AT&T announced on February 23, 2004, that they had reached an out-of-court resolution of all claims the two companies have had against each other, both before and after MCI filed Chapter 11 petitions in July 2002. The agreement includes resolution of AT&T's call routing claims against MCI and MCI's dismissal of its contempt of court motion against AT&T.

As MCI approaches emergence from Chapter 11, it remains focused on its future as a leader in the telecommunications industry and prepared to continue serving the Missouri telecommunications market.
