**ORDER GRANTING EXTENSION OF TIME TO FILE EXHIBIT AND
EXTENDING DEADLINE FOR FILING POST-HEARING BRIEFS**

The Commission held an ancillary evidentiary hearing in these matters on March 30, 2007. During the hearing, Cathy J. Orler offered Exhibit 110 into evidence. Ms. Orler attempted to authenticate this one document out of a group of many documents that she had obtained from the Department of Natural Resources.

At hearing, the Commission provided the parties with specific instructions regarding a procedure to allow the parties to adequately examine this document to determine if it has proper authentication. The parties were directed to follow that procedure and Ms. Orler was directed to file Exhibit 110 no later than April 6, 2007.

On April 6, Ms. Orler offered Exhibit 110 into evidence and on April 9, Respondents objected to the extent that the document offered was an excerpt and not the complete exhibit. Consequently, Ms. Orler was directed to offer the complete exhibit into evidence no later than April 16.

On April 12, Mr. Orler filed a request for an extension of time to file the complete form of this exhibit. Ms. Orler states that she is awaiting the receipt of the complete and authenticated document from the custodian of records at the Department of Natural Resources. Ms. Orler requests the Commission to extend the deadline for filing this exhibit to April 20.

The Commission finds Ms. Orler's request to be reasonable and shall grant it. The Commission notes that the deadline for filing post-hearing briefs in this matter is currently set for April 20. This pending evidentiary matter will not be resolved until that same date, and there is an additional pending evidentiary matter involving the filing of exhibit number 105 that still needs to be resolved. Because the parties should have the benefit of having all proper evidence before them prior to the completion of their briefs, the Commission will extend the deadline for filing post-hearing briefs until April 27 so that both of these evidentiary matters can be resolved prior to the parties completion of their briefs.

IT IS ORDERED THAT:

1. No later than April 20, 2007, Cathy J. Orlor shall file with the Commission Exhibit 110 in its complete and authenticated form.
2. The current deadline for filing post-hearing briefs of April 20, 2007 shall be extended until April 27, 2007
3. This order shall become effective on April 13, 2007.
