# NOTICE OF TRANSFER OF ASSETS AND MOTION FOR EXPEDITED TREATMENT OF ADOPTION TARIFFS

COMES NOW Missouri-American Water Company (MAWC) and for its Notice of Transfer of Assets and Motion for Expedited Treatment of Adoption Tariffs states as follows:

- 1. In its May 7, 2011 Order Granting Applications (Order), the Missouri Public Service Commission ordered MAWC to comply with the Unanimous Stipulation and Agreement (Stipulation) entered into by and among Roark Water & Sewer, Inc.(Roark), MAWC, the Staff of the Missouri Public Service Commission, and the Office of Public Counsel. Among other things, The approved Stipulation required that MAWC "shall be authorized to file revised tariff sheets in the current Roark water and sewer tariffs containing new CIAC fees totaling \$2,450 per customer applicable to the next 300 new customers in Forest Lake subdivision, to expire twenty (20) years after the effective date of the revised tariff sheets." (Stipulation, paragraph 3)
- 2. The Order requires MAWC to "notify the Commission within five (5) business days after the subject assets have been transferred from Roark to MAWC."
- MAWC hereby notifies the Commission that the assets were transferred on July 29,
   2011.

4. The Order also states that MAWC shall, "within five (5) business days after the

subject assets have been transferred, adopt Roark Water & Sewer, Inc.'s currently approved tariffs

by filing an adoption notice for each of those tariffs.

5. Contemporaneously herewith, MAWC is filing the adoption notices, as well as the

tariff sheets consistent with the approved Stipulation, with issue dates of August 2, 2011. Copies of

these sheets are attached as Exhibits to this motion.

6. A tariff generally becomes effective 30 days after date of issue. 4 CSR 240-2.065(2).

MAWC is seeking expedited treatment for the approval of the amended tariff within 10 days, that is,

August 12, 2011. There will be no negative effect on MAWC's new customers formerly served by

Roark, or on the general public, if the Commission acts by August 12, 2011.

7. This Motion for Expedited Treatment was filed as soon as it could have been – within

two business days of the date that the assets of Roark were transferred to MAWC, per the

Commission's Order that the adoption notices be filed "within five (5) business days after the subject

assets have been transferred."

WHEREFORE, MAWC prays that the Commission issue its order approving the

adoption notices and referenced tariff sheets by August 12, 2011, and grant any and all other

appropriate relief.

# Commodity Charge (1)

\$4.85 per 1,000 gallons for usage over the amount included in the monthly minimum charge

(1) The monthly minimum charges include the first 2,000 gallons of usage. Residential customers' monthly commodity charge amounts for the entire year will be based on the average monthly water usage in the months of December, January and February. Commercial customers' commodity charge amounts will be based on actual monthly water usage.

### **Connection (CIAC) Fees**

The Company is authorized to condition service to the initial applicant for sewer service at a single family residence upon the payment of a one-time charge of \$2,150. This connection fee is in addition to any other fees authorized under Rate Schedule B.
