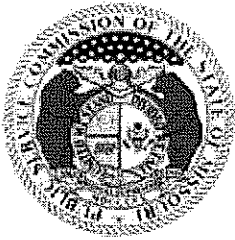
On June 19, 2015, the Office of the Public Counsel filed a complaint with the Missouri Public Service Commission against Fawn Lake Water Corp. and Rachel Hackman, alleging the Respondents are operating a water utility to serve the public without having obtained the required authorization from the Commission. Respondents' answer to Public Counsel's complaint was due by July 20. Despite Respondents' failure to answer, Public Counsel has not requested any further action by the Commission.

So that the Commission can be kept abreast of developments, Public Counsel will be directed to file a status report.

THE COMMISSION ORDERS THAT:

1. The Office of the Public Counsel shall file a status report no later than September 8, 2015.

2. This order shall be effective when issued.




