**ORDER SETTING ASIDE STAY, DIRECTING  
RESPONDENT TO FILE AN ANSWER, AND THE OFFICE OF PUBLIC  
COUNSEL TO FILE A STATUS REPORT**

On September 8, 2017, the Commission issued an *Order Directing the Parties to File a Status Report*. On September 14, 2017, the Staff of the Missouri Public Service Commission filed *Staff Status Report* in response. Neither the Office of Public Counsel nor Respondent filed a status report.

On November 3, 2015, the Commission granted *Respondent's Motion to Stay Cases* based on the representation that the parties were attempting to reach an amicable resolution, and no party opposed staying the cases. That stay is set aside and the case shall proceed forward.

Respondents have not filed an answer to the Office of Public Counsel's complaint, Respondent is directed to answer the complaint within thirty days from the

issuance of this order or risk a potential default determination being entered in favor of Complainant.

The Office of Public Counsel has not filed a status report and is directed to file one within thirty days or risk dismissal of the case for failure to prosecute their complaint.

**THE COMMISSION ORDERS THAT:**

1. Respondent shall file an answer to the Office of Public Counsel's complaint no later than October 25, 2017.
2. The Office of Public Counsel shall file a status report no later than October 25, 2017.
3. This order shall be effective when issued.
