**ORDER SETTING DEADLINE FOR RESPONSE TO MOTION  
FOR DEFAULT DETERMINATION**

Issue Date: September 20, 2016

Effective Date: September 20, 2016

On September 19, 2016, the Commission's Staff filed a *Motion for Default Determination*. Staff previously filed a *Complaint* against Missouri Utilities Company ("Missouri Utilities" or "Respondent") alleging failure by Respondent to comply with the Commission's annual reporting requirements. The Commission issued an order providing notice of the *Complaint* and directing Missouri Utilities to file an answer no later than August 13, but no answer was filed.

Staff's motion requests the Commission enter a default judgment against Missouri Utilities and authorize its General Counsel's Office to seek civil penalties. The Commission will set a deadline for Respondent to file a response to Staff's motion.

**THE COMMISSION ORDERS THAT:**

1. Missouri Utilities may file a response to Staff's *Motion for Default Determination* no later than September 29, 2016.

2. This order shall be effective when issued.
