#### **STATUS REPORT**

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), by and through the undersigned counsel, and for its *Status Report*, states as follows:

- 1. On June 27, 2011, Eric C. Larson (Larson) filed a formal complaint with the Commission against Woodland Manor Water Company (Woodland Manor).
- 2. Woodland Manor filed a *Response* to the Complaint on July 21, 2011 and, upon further direction from the Commission, its attorney, Gregory Gibson, entered his appearance and filed an *Answer* on August 5, 2011.
- 3. On October 25, 2011, the Commission issued an *Order Granting Motion to Continue and Directing Filing* which required Staff to file a status report on ownership for the business for which service is at issue no later than January 24, 2012. This filing complies with that *Order*.
- 4. On October 28, 2011, Staff filed, and the Commission granted, a *Joint Motion to Stay Procedural Schedule* until further confirmation as to the status of the LLC in question.
- 5. Staff received the attached Certificate of Termination, marked Exhibit A, signed by the Missouri Secretary of State indicating that the existence of Kimberling Oaks Resort, LLC ceased on November 3, 2011.

6. As a result, it appears that this matter may be set for procedural schedule if the Commission deems appropriate.
