This letter is to acknowledge receipt of the "Motion for Extension of Time to File Response," received on September 19, 2005, and to respond to that request being made.

Item No. 3, of the motion, addresses Folsom Ridge's need for additional time to weigh whether it should suggest voluntary mediation for both complaints. I, myself, as the complainant in this case being referenced, have been mediating with the respondent, Folsom Ridge, for nearly 7 years, with no resolve; thereby resulting in my action of filing a Formal Complaint with the Public Service Commission. As per the attached, "Notice of Complaint," outlining the mediation process of the PSC, I am declining mediation.

However, since numerous other Formal Complaints are in the process of being filed, by other Big Island property owners, concerning Folsom Ridge and similar and related matters, and an extension of time is requested and/or is necessary for the consolidation of these complaints by the Commission, I would not be opposed to serving the interests of fairness to, and the efficiency of the

Commission's administration of the complaint processes, by agreeing to the extension of time up to, and including September 29, 2005.

NOTICE OF COMPLAINT

On August 18, 2005, Cathy J. Orler filed a complaint with the Missouri Public Service Commission against Folsom Ridge, LLC (owning and controlling the Big Island Homeowners' Association), a copy of which is enclosed. Pursuant to 4 CSR 240-2.070, Folsom Ridge, LLC, shall have 30 days from the date of this notice to file an answer or to file notice that the complaint has been satisfied.

In the alternative, Folsom Ridge, LLC, may file a written request that the complaint be referred to a neutral third-party mediator for **voluntary mediation** of the complaint. Upon receipt of a request for mediation, the 30-day time period shall be tolled while the Commission ascertains whether or not the Complainant is also willing to submit to voluntary mediation. If the Complainant agrees to mediation, the time period within which an answer is due shall be suspended pending the resolution of the mediation process. Additional information regarding the mediation process is enclosed.

If the Complainant declines the opportunity to seek mediation, Folsom Ridge, LLC, will be notified in writing that the tolling has ceased and will also be notified of the date


by which an answer or notice of satisfaction must be filed. That period will usually be the remainder of the original 30-day period.

All pleadings (the answer, the notice of satisfaction of complaint or request for mediation) shall be mailed to:
