On March 6, 2003, the Missouri Public Service Commission approved a Territorial Agreement between the City of Union, Missouri, and Public Water Supply District No. 1 of Franklin County, Missouri. On September 20, 2006, the City of Union and Franklin County filed an Addendum to the Territorial Agreement. The Addendum will essentially allow Union to provide water service to customers located in Franklin County's service area. On November 3, the Staff of the Commission filed its response to the addendum and believes it is in compliance with the Territorial Agreement and has no objection. The Office of the Public Counsel did not file an objection.

Consistent with the Notice issued in this matter on November 21, 2002, regarding the parties' Territorial Agreement, the Commission will direct that similar notice of this application be sent to all interested persons. The Commission will also set an intervention deadline.

The Commission determines that notice of this application should be given by the Commission's Data Center sending a copy of this order to the County Commission of Franklin County, Missouri. The Commission further determines that the Information Office

of the Commission shall make this Order and Notice available to the members of the General Assembly who represent constituents in Franklin County, Missouri and to the newspapers and other media which serve Applicants' service areas.

Persons wishing to intervene in this matter shall have 14 days from the date of this order to file an application to intervene with the Secretary of the Commission and shall send a copy of the application to all parties as directed below.

IT IS ORDERED THAT:

1. The Commission's Data Center shall send a copy of this order to the County Commission of Franklin County, Missouri.

2. The Commission's Information Officer shall make this Order and Notice available to the members of the General Assembly who represent constituents in Franklin County, Missouri and to the newspapers and other media which serve Applicants' service areas.
