On March 11, 2008, Missouri-American Water Company submitted to the Commission a Water and/or Sanitary Sewer Service Agreement it has reached with MLM Properties, Inc. MAWC said this agreement is necessary for the expansion and improvements to the Incline Village service area in Warren County, Missouri, as approved in Commission Cases WA-2008-0012 and SA-2008-0019. Further, MAWC states that the agreement is subject to approval by the Commission.

MLM Properties did not join in MAWC's application. The Commission finds that MLM Properties is a proper party, and will add MLM Properties as a party to this case.

The Commission further finds that proper persons should be allowed 20 days from the issuance of this order to file a motion for leave to intervene. The Commission's Data Center shall serve a copy of this order upon the county commission of Warren County. In addition, the Commission's Public Information Office shall make notice of this order available to the media serving Warren County and to the members of the Missouri General Assembly representing Warren County.
