On April 2, 2009, the City of Centralia, Missouri and Public Water Supply District No. 10 of Boone County, Missouri filed a joint application seeking approval of a third amendment to a written territorial agreement concerning territory within Boone County, Missouri.

The Commission finds that notice of this application should be given to the general public and others who may be particularly interested. The Commission's Data Center shall mail a copy of this notice to the County Commission of Boone County and to the Department of Natural Resources of the State of Missouri. Additionally, the Commission's Public Information Officer shall make notice of this order available to the media serving Boone County and to the members of the General Assembly representing Boone County.

To afford those who wish to intervene an opportunity to do so, the Commission will set an intervention deadline. After which, if no party requests intervention and opposes the

application, the Commission will require the Staff of the Commission to file its recommendation.

THE COMMISSION ORDERS THAT:

1. The Missouri Public Service Commission's Data Center shall serve notice as set out in the body of this order.

2. The Missouri Public Service Commission's Information Officer shall serve notice as set out in the body of this order.
