NOTICE OF APPLICATION AND ORDER DIRECTING FILING

On January 10, 2017, Missouri-American Water Company (MAWC), a Missouri corporation, and Audrain Public Water Supply District No. 1 (the District), a Missouri public water supply district, (collectively referred to as, "Joint Applicants") filed a joint application asking the Commission to approve a territorial agreement pursuant to Section 247.172, RSMo.

According to the application, a dispute arose between MAWC and the District with regard to overlapping territories within the city limits of Mexico, Missouri. As a result the parties were engaged in a federal law suit in the U.S. District Court for the Eastern District of Missouri. Following extensive settlement negotiations from that litigation, the parties reached the territorial agreement set out with the application. In conjunction with the territorial agreement, the Joint Applicants agreed to certain boundaries to be served exclusively and that certain existing customers will continue to be served by their current providers. Additionally, the Joint Applicants agreed that the following properties located within the city limits of Mexico, Missouri, will no longer be served by the District and, instead, shall be served by MAWC. Those properties are as follows: 2781, 2797,

2813, 2825, 2871, 2875, 2935, 2977, and 3100 S. Clark and 440 Kelley Parkway, Mexico, Missouri. The Joint Applicants agreed that all other customers would remain with their current water service provider.

The Commission will direct notice of the filing of this territorial agreement to be sent to the public. In addition, the Commission will establish a deadline for the filing of applications to intervene and will order its Staff to file a recommendation regarding the joint application. If no party files a motion for an evidentiary hearing, the Commission may deem the right to an evidentiary hearing waived. The controlling statute requires the Commission to rule on the application no later than 120 days from the date the application was filed.

THE COMMISSION ORDERS THAT:

- The Commission's Data Center shall send a copy of this order to the County Commission of Audrain County, Missouri, and to the Mayor of the City of Mexico, Missouri.
- 2. The Commission's Public Information Office shall make notice of this order available to the members of the General Assembly representing Audrain County, Missouri and to the newspapers serving that county.
- 3. Missouri-American Water Company and Audrain Public Water Supply District No. 1, shall jointly notify each of the customers or property owners whose water service will be affected by this Territorial Agreement no later than January 31, 2017, by serving them with a copy of this notice.

4. Any interested person or party wishing to intervene in this matter shall file an application to intervene **no later than February 10, 2017** electronically using the Commission's Electronic Filing and Information System (EFIS) at https://www.efis.psc.mo.gov/mpsc/ or with:
