**ORDER SCHEDULING AN EVIDENTIARY HEARING**

On March 14, 2017, the Staff of the Commission filed a Petition with the Missouri Public Service Commission asking the Commission direct its General Counsel to petition the Circuit Court of Cole County to appoint a receiver for Ridge Creek Water Company, LLC, and Ridge Creek Development, L.L.C. Staff also asks the Commission to appoint an interim receiver for those companies. On April 14, the owners of Ridge Creek Water and Ridge Creek Development filed their consent to the appointment of a receiver for both companies.

At a procedural conference held on April 19, legal counsel for Staff explained that Staff believes the owners of Ridge Creek Water and Ridge Creek Development may intend to essentially abandon the water system. Counsel also indicated that, at least at this time, the water system is operating and continues to provide service to its customers.

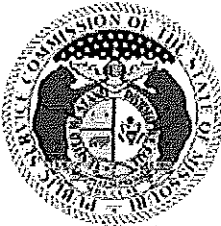
The Commission is concerned about this situation and will schedule an expedited hearing regarding Staff's petition. At the hearing, Staff will need to present sufficient evidence to establish that the requirements for appointment of a receiver found in

Section 393.145.1, RSMo 2016 have been satisfied. As part of those requirements, Staff will need to establish that Ridge Creek Development meets the definition of a water corporation.

**THE COMMISSION ORDERS THAT:**

1. An evidentiary hearing is scheduled for May 2, 2017 at 9:00 a.m., at the Commission's office in the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. This building meets accessibility standards required by the Americans with Disabilities Act. 


