ORDER SETTING PREHEARING CONFERENCE

On August 20, 2018, Missouri-American Water Company (“MAWC”) filed an application and petition with the Missouri Public Service Commission pursuant to Sections 393.1000, 393.1003, and 393.1006, RSMo 2016, and Commission Rules 4 CSR 240-2.060 and 3.650, requesting that the Commission authorize it to change its Infrastructure System Replacement Surcharge (“ISRS”). Section 393.1006.2(3), RSMo, requires that the Commission act on the application no later than 120 days after the petition was filed; therefore, the Commission must issue an order regarding the application effective no later than December 18, 2018.¹

Having received the application, Staff’s recommendation, a response from MAWC, and a response from the Office of Public Counsel, this matter is ready to be set for hearing. In order to discuss a procedural schedule and possible settlement of this matter, the Commission will set a prehearing conference. For their convenience, the parties may appear by telephone as set out below.

¹ Pursuant to Section 393.1015(3) the Commission may hold a hearing prior to reaching its decision.

THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on November 15, 2018, at 1:00 p.m.
2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate in the conference or hearing shall contact the Commission, not later than the day before the conference. 3. This order shall be effective when issued.
