#### STAFF RECOMMENDATION

**COMES NOW** the Staff of the Missouri Public Service Commission (Staff), through counsel, and recommends that the Commission approve the proposed tariff sheets Missouri-American Water Company (MAWC) filed December 20, 2021. In support, Staff states:

- 1. The Commission issued its *Order Approving Transfer of Assets and Granting Certificate of Convenience and Necessity* (Order) on December 1, 2021 granting MAWC a certificate of convenience and necessity to provide water and sewer service in Orrick, Missouri. The Commission ordered MAWC to submit tariff sheets to become effective before closing on the assets.<sup>1</sup>
- 2. On December 20, 2021, MAWC filed proposed tariff sheets bearing effective dates of January 19, 2022.
- 3. Staff reviewed MAWC's proposed tariff sheets and determined that they comply with the Commission's Order. Staff recommends that the Commission approve the proposed tariff sheets.
