## ORDER DIRECTING STAFF RESPONSE

On July 1, 2022,<sup>1</sup> Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application for a certificate of convenience and necessity (CCN) for a water system currently served by Tan Tar A State Road, LLC (Tan Tar A), located in Camden County. The Commission directed the Staff of the Commission (Staff) to provide its recommendation.

Staff's recommendation cited several examples of information Staff had requested, but not received. Staff requested the Commission to order Confluence Rivers to produce the requested information.

On November 3, Confluence Rivers responded to Staff's recommendation. Generally, Confluence Rivers states it has complied with Staff's requests for information. Confluence Rivers then requests the Commission to order Staff to file an updated recommendation.

The Commission finds the request reasonable and will order Staff to respond with a status report or an updated recommendation.
