ORDER GRANTING REQUEST FOR EXTENSION

On July 1, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence Rivers) filed an application for a certificate of convenience and necessity (CCN) for a water system currently served by Tan Tar A State Road, LLC (Tan Tar A), located in Camden County. The Commission directed the Staff of the Commission (Staff) to provide its recommendation or a request for an extension of time on or before August 23, 2022.

Staff timely requested an extension of time due to outstanding data requests Staff has submitted. Staff requests an extension to file its recommendation until October 24, 2022.

Due to the impact the additional information may have on Staff's report, the Commission finds the extension request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension of time is granted. Staff shall file its recommendation, or a request for further extension, on or before October 24, 2022.
2. This order shall be effective when issued.
