On June 22, 2023, Missouri-American Water Company (MAWC) filed the above-referenced applications. The applications seek, among other things, authority for MAWC to acquire and operate the water and sewer systems of The City of Ironton.

The Commission will direct notice of the application be given to the county commission and local media serving residents of Iron County, Missouri. The Commission will also direct notice of the application to the General Counsel for the Missouri Department of Natural Resources and will further set a deadline for interested parties to intervene.

2. The Commission’s Data Center shall provide a copy of this order to the General Counsel for the Missouri Department of Natural Resources.

4. Any person wishing to intervene in this matter shall file an application to intervene no later than July 10, 2023. The application shall be filed in the Commission's Electronic Filing and Information System ("EFIS") or with the Secretary of the Commission. Comments on the application can also be made in EFIS.

5. This order shall be effective when issued.
