#### **COMPLAINT**

COMES NOW, the Office of the Public Counsel, and hereby files this Complaint against Warren County Water & Sewer Company before the Missouri Public Service Commission. This Complaint alleges that the Company has failed to adhere to the Commission's rules and regulations regarding disputed bills. Specifically, the Company has acted contrary to the disputed billing rules in connection with the account of customers residing at 2864 Ricky Drive (the Houks). In support of this Complaint, Public Counsel states the following:

- 1. The customers receiving service at 2864 Ricky Drive received a bill which included a "reconnect charge." That bill alleged that it was for service from "9-25-03 to 10-30-03" and carried a due date of "11-21-03." That bill included a \$2 late charge and a \$20 "reconnect fee." The total amount due by 11-2-03, according to this bill is \$54.90, including those charges. (See Attached Exhibit.)
- 2. The Customer also received a notice that \$22 of a previous bill was "past due" and that the Customer's service would be disconnected on November 10, 2003. The "past due" portion alleged consists of the same \$2 late charge and \$20 reconnect charge which the other bill states is due on November 21.

- 3. The Customer denies having been disconnected or reconnected.
- 4. The Customer disputes owing a late charge or a reconnect charge.
- 5. The Company's records, also contained in the exhibit show the following: the Customer was billed \$72.22 at the beginning of October. The Company posted a payment to the customer's account of \$56.90 on Oct. 8. On that same date, the Company posted a charge for reconnect fee of \$20. There is no indication that such amount was billed to the customer. On October 29, the Company posted a payment from the customer in the amount of \$22, which would have been the known outstanding balance for the customer on that date AND a \$2 late charge. The first written notice to the customer of the \$20 reconnection charge and the first notice of a late charge came to the customer on the current bill with a due date of 11-21-03. (See attached Exhibit.)
- 6. The Customer disputes the propriety to a reconnect fee, and disputes that she should be assessed a late charge. Even if such charges should be later determined to be reasonable, they are not due until Nov. 21. Therefore, any disconnection would violate the Company's tariffs and Commission rules, and be unlawful and unreasonable.

WHEREFORE, it is respectfully requested that the Commission issue an Order prohibiting Warren County Water and Sewer from disconnecting the Customer's service until this matter can be resolved, and referring the parties to mediation.

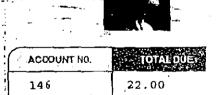
