## OPC COMMENTS TO STAFF RECOMMENDATION

**COMES NOW** the Office of the Public Counsel ("OPC") and, pursuant to the Commission's November 8, 2017 *Order Adopting Procedural Schedule*, submits its comments on the Staff of the Public Service Commission ("Staff") Recommendation filed January 5, 2018. OPC comments as follows:

- 1. On September 14, 2017, Liberty Utilities (Missouri Water) LLC and Ozark International, Inc. filed their *Joint Application for Authority to Transfer Assets*.
- 2. On November 8, the Commission adopted the parties' proposed procedural schedule, wherein the Commission directed Staff to filed its recommendation no later than January 5, 2018; and for parties to submit comments to Staff's recommendation not later than January 15.
- 3. On January 5, 2018, Staff submitted its *Staff Recommendation*, wherein it recommended the Commission approve the transfer, subject to sixteen conditions.
- 4. Upon review of Staff's recommendation, OPC supports Staff's recommendation that the Commission approve the application subject to the sixteen conditions.

5. OPC remains in discussions with Staff to address a minor accounting adjustment that would have a *de minimis* revenue requirement impact. While these discussions continue, the resolution of the issue in OPC's favor or Staff's favor would not affect OPC's comment in support Staff's Recommendation subject to the conditions detailed therein.

**WHEREFORE**, OPC provides this comment in support of Staff's Recommendation subject to the conditions therein for the Commission's consideration.
