On January 30, 2018, Missouri-American Water Company filed a response to Staff's recommendation objecting to two conditions proposed by Staff for approval of the application. No further filings have been made in this proceeding. The Commission is aware that the parties are involved in a rate case that is set for hearing in a few days, so no action will be taken on this matter for approximately 30 days. The Commission will order its Staff to file a joint status report stating if the parties have reached a settlement, whether a procedural conference is necessary, or whether the matter should be set for an evidentiary hearing.

THE COMMISSION ORDERS THAT:

1. The Staff of the Missouri Public Service Commission shall file a joint status report no later than March 20, 2018.

2. This order shall become effective when issued.
