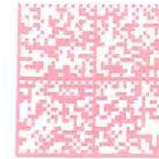

**ORDER APPROVING TARIFFS**

On April 22, 2019, Confluence Rivers Utility Operating Company, Inc. ("Company") filed proposed tariff sheets YW-2019-0188<sup>1</sup> and YS-2019-0189.<sup>2</sup> These tariff sheets were filed in response to the Commission's February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* ("Order"). This Order required the Company to adopt the existing sewer and water tariffs currently in effect for The Willows Utility Company. The tariff sheets are proposed to become effective on May 22, 2019. The Company also filed substitute tariffs on April 24, 2019.

Staff filed a Recommendation on April 26, 2019. The Recommendation stated that the tariffs as substituted comply with the Commission's Order, and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff's Recommendation.

The Commission has reviewed the tariff filings and Staff's Recommendation, and determines that the filings comply with the Commission's order.




