ORDER REQUIRING LAKE PERRY TO REPLY AND STAFF TO FILE RECOMMENDATION

Issue Date: December 3, 2018 Effective Date: December 3, 2018

On November 21, 2018, Lake Perry Lot Owners' Association ("Intervenor") filed a Motion to Compel Answers to Certain Data Requests ("Motion"). On November 30, 2018, Confluence Rivers Utility Operating Company, Inc., (the "Company") filed a Response to Motion to Compel ("Response"). The Commission has carefully reviewed the Motion and Response. The Commission notes that the dispute turns on the question of whether the information which Intervenor seeks is relevant or reasonably calculated to lead to the discovery of admissible evidence. The Commission, accordingly, anticipates that its ruling on the Motion will depend upon the relationship between the evidence to be discovered and the ultimate material issues which the Commission must resolve in this cause. The Commission also notes that its Order Adopting Procedural Schedule required the parties to file a List of Issues on or by January 17, 2019.

The Commission will order the Intervenor to Reply to the Company's Response and Staff to file a recommendation on the Motion. The Office of Public Counsel ("OPC) may also file a recommendation. The Commission will order the Intervenor, Staff (and OPC, if it

files a recommendation) to brief the discovery question in terms of the ultimate material issues which the Commission must resolve in this cause, listing those issues with exact specificity.

THE COMMISSION ORDERS THAT:

- 1. Lake Perry Lot Owners' Association ("Intervenor") is ordered to file a Reply to the Response mentioned in the body of this Order no later than December 7, 2018.
- 2. The Staff of the Missouri Public Service Commission ("Staff") is ordered to file a recommendation concerning the Motion mentioned in the body of this Order ("Motion") no later than December 7, 2018.
- 3. The Office of Public Counsel ("OPC") may file a recommendation on the Motion. If OPC chooses to file a recommendation, OPC shall do so no later than December 7, 2018.
- 4. Any party filing a reply or recommendation shall list with exact specificity every ultimate material issue involved in the Motion which the Commission will have to resolve in this cause.
 - 5. This order will be effective when issued.
