ORDER SUSPENDING THE PROCEDURAL SCHEDULE

On October 17, 2018, the Public Service Commission of the State of Missouri ("Commission") issued an *Order Adopting Procedural Schedule*.² On December 10, 2018, the Commission issued its *Order Amending Procedural Schedule and Requiring Status Report*, setting back certain deadlines in connection with ongoing settlement discussions. That Order required the parties to file a Stipulation and Agreement or a Status Report no later than December 14, 2018. On December 14, 2018, the parties filed a *Unanimous Stipulation and Agreement* (the "Stipulation"). The Stipulation states that per its terms, Confluence Rivers Utility Operating Company, Inc., (the "Company") will be withdrawing certain requests from its application. The Stipulation states that the Parties agree and intend that the Stipulation will settle all remaining issues in this case. The parties ask the Commission to approve the Stipulation. The Commission will issue its Order Suspending the Procedural Schedule(s) pending the Commission's consideration of the Parties' Stipulation.
