On April 24, 2019, Confluence Rivers Utility Operating Company, Inc. ("Company") filed proposed tariff sheets YW-2019-0191. These tariff sheets were filed in response to the Commission's February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and* Necessity ("Order"). This Order required the Company to adopt the existing sewer and water tariffs currently in effect for Evergreen Lake Water Company. The Evergreen Lake Water Company tariff sheets are proposed to become effective on May 24, 2019.
