NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT

Issue Date: May 16, 2019

On April 24, 2019, Confluence Rivers Utility Operating Company, Inc. ("Company") filed proposed tariff sheets YW-2019-0191. These tariff sheets were filed in response to the Commission's February 14, 2019, *Order Approving Stipulation and Agreement and Granting Certificates of Convenience and Necessity* ("Order"). This Order required the Company to adopt the existing sewer and water tariffs currently in effect for Evergreen Lake Water Company. The Evergreen Lake Water Company tariff sheets are proposed to become effective on May 24, 2019.

Staff filed a *Recommendation to Approve Tariff Sheets* ("Recommendation") on May 6, 2019. The *Recommendation* stated that the tariffs comply with the Commission's Order and recommended that the Commission approve them. The Commission received no other responses to the tariff filing or Staff's *Recommendation*.

Given Staff's recommendation and no opposition to the tariff's taking effect, the Commission will allow Tariff No. YW-2019-0191² to become effective on May 24, 2019.


