

Wilden Heights Water Company on or about December 5, 2002.





ORDER DIRECTING FILING


On November 27, 2002, the Missouri Public Service Commission issued an order authorizing the sale of the Wilden Heights Water Company from Ronald and Nancy Minton to the Wilden Heights Homeowners Association. In the order, the Commission required that Wilden Heights notify the Commission of the closing of the sale. The Commission has not been notified that the sale of the company has been closed.

IT IS THEREFORE ORDERED:

1. That the Wilden Heights Water Company shall notify the Commission, not later than July 9, 2003, of whether the sale of the Company from Ronald and Nancy Minton to the Wilden Heights Homeowners Association is closed.
2. That this order shall become effective on June 26, 2003.
