**ORDER DIRECTING NOTICE AND SETTING INTERVENTION DATE**

Issue Date: January 5, 2006

Effective Date: January 5, 2006

This order provides notice of the application to establish an Infrastructure System Replacement Surcharge (ISRS) filed by Missouri-American Water Company. This order also sets an intervention deadline.

On January 3, 2006, Missouri-American Water Company filed an application with the Missouri Public Service Commission under Sections 393.1000, 393.1003 and 393.1006, RSMo Cum. Supp. 2005, requesting that the Commission authorize the company to establish an Infrastructure System Replacement Surcharge for mains, valves and hydrants. Section 393.1006.2(3) requires the Commission to act on Missouri American's application no later 120 days after it was filed. That means that the Commission must issue a report and order regarding the application effective no later than May 3, 2006. With its application, Missouri-American filed a tariff that will implement the surcharge. Unless the Commission acts to suspend that tariff, it will become effective on February 2, 2006.

Section 393.1006.1(2) requires that the Commission publish notice of Missouri-American's filing. Therefore, notice of this application should be made to the general public and those who may be interested, and a date set for intervention requests.

The Commission will require that its Data Center mail a copy of this notice to the commission of St. Louis County. Also, the Commission's Public Information Office shall make notice of this order available to the media serving St. Louis County and to the members of the General Assembly representing St. Louis County.

**IT IS THEREFORE ORDERED:**

1. That the Data Center of the Missouri Public Service Commission shall serve notice of this order upon the County Commission of St. Louis County.
2. That the Information Officer of the Missouri Public Service Commission shall serve notice as set out in the body of this order.
3. That any person wishing to intervene in this matter shall file an application to do so no later than January 25, 2006. Such application shall be filed with:
