STAFF RECOMMENDATION FOR APPROVAL OF TARIFF SHEETS

COMES NOW, the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its *Staff Recommendation for Approval of Tariff Sheets* states as follows:

- 1. On September 23, 2011, Missouri American Water Company ("MAWC") and Public Water District No. 2 of St. Charles County, Missouri ("District"), collectively "Applicants," filed with the Missouri Public Service Commission a joint application seeking approval of a Territorial Agreement.
- 2. On November 3, 2011, Staff filed its Staff Recommendation to Approve Territorial Agreement.
- 3. On November 15, 2011, the Commission issued its *Report and Order Approving Addendum to Territorial Agreement (Report and Order)* which approved the requested Addendum and ordered MAWC to file revised tariff sheets to reflect the limitations the Addendum places on its service area.
- 4. On November 16, 2012, MAWC filed revised tariff sheets, which were assigned Tariff Tracking Nos. YW-2013-0232 and YW-2013-0233 to comply with the Commission's *Report and Order*.

- 5. On November 16, 2012, the Commission ordered Staff to file a Recommendation regarding the above-mentioned tariff sheets by December 6, 2012. This filing complies with that order.
- 6. The Commission has the authority to approve the proposed tariff sheets pursuant to Section 393.140(11), RSMo (2000).
- 7. Jerry Scheible, P.E., of the Commission's Water and Sewer Unit, reviewed the revised tariff sheets filed with the Commission, and states that to the best of his knowledge, information, and belief, that the proposed sheets substantially comply with the Commission's *Order. See Affidavit of Jerry Scheible*, attached and incorporated by reference herein as Attachment A.

WHEREFORE, Staff respectfully submits *Staff's Recommendation for Approval of Tariff Sheets* and Staff supports the Company's tariff filing, Tariff Tracking Nos. YW-2013-0232 and YW-2013-0233, which were filed in this matter. Staff respectfully recommends the Commission approve the Company's filing along with any other relief the Commission deems appropriate.
