On January 11, 2012, Highway H Utilities, Inc. ("Highway H") filed an application with the Missouri Public Service Commission ("Commission") seeking to sell and transfer a portion of its works and systems to the City of Waynesville, Missouri ("City"). Highway H currently operates a water system known as the Hunter's Pointe Water System located in Pulaski County, Missouri. Highway H and the City have entered into an Agreement for Sale of Water System ("Sales Agreement") providing for the sale of all the assets, property and real estate connected with the Hunter's Pointe Water System to the City. A copy of the Sales Agreement describing the terms of the transaction has been included with the application. Although the City is a party to the Sales Agreement, it did not join in the application. Since the City is a party to the Sales Agreement, the Commission will add the City as a party to the case.

Section 390.190.1, RSMo, requires that when transactions such as the one described in the Sales Agreement are submitted to the Commission for approval, the Commission must send notice "to the county clerk of each county in which any portion

of a political subdivision which will be affected by such disposition is located." Since the application states that the water facilities being sold are located in Pulaski County, the Data Center of the Commission shall send a copy of this order to the County Clerk of Pulaski County, Missouri.

Proper persons wishing to intervene shall have 20 days from the date of this order to file an application to intervene with the Secretary of the Commission. Any application to intervene must be filed no later than February 1, 2012. The Commission's Staff shall also file its recommendation or preliminary response as directed below.

THE COMMISSION ORDERS THAT:

- The Data Center shall send a copy of this order to the County Clerk of Pulaski County, Missouri.
 - 2. The City of Waynesville, Missouri is made a party to this case.
- 3. Any interested person wishing to intervene in this case shall file an application to intervene on or before February 1, 2012 to the following:

4. No later than February 15, 2012, the Staff of the Missouri Public Service Commission shall file a recommendation regarding approval of the application or a preliminary response to the application.
