# STAFF'S RECOMMENDATION TO APPROVE TARIFF SHEETS AS IN COMPLIANCE WITH COMMISSION ORDER

**COMES NOW** the Staff of the Missouri Public Service Commission, by and through counsel, and for its recommendation to approve the compliance tariff sheets filed April 4, 2014, by Missouri-American Water Company ("MAWC" or "Company") in this matter respectfully states:

- 1. On April 4, 2014, MAWC filed compliance tariff sheets pursuant to the Commission's March 12, 2014 *Order Approving Transfer of Assets and Certificate of Convenience and Necessity and Granting Waiver*. MAWC also requested expedited treatment and approval of the proposed tariffs sheets on less than thirty days' notice.
- 2. On April 7, 2014, the Commission filed its *Order Directing Staff to File a Recommendation and Setting Deadline for Response*, ordering Staff to file a recommendation as to whether the tariff sheets are in compliance with the

Commission's March 12 order and whether Staff objects to MAWC's request for expedited treatment.

- 3. Staff has reviewed the tariff sheets filed by MAWC. At Staff's request, MAWC filed two substitute tariff sheets on April 9, 2014, to make a clarification and to correct a typographical error. Staff finds that the tariff sheets comply with the Commission's March 12 order. An affidavit from James A. Merciel, Jr., Utility Regulatory Engineering Supervisor in the Water and Sewer Unit, is attached hereto.
- 4. The tariff sheets filed by MAWC bear an effective date of May 4, 2014, but MAWC requests the Commission approve the tariff sheet so that they take effect upon the filing of the Staff's recommendation regarding the approval of MAWC's compliance tariffs. In support of its motion, MAWC states that, pursuant to § 393.140(11) RSMo, good cause exists to make the Company's compliance tariff sheet effective on less than thirty (30) days' notice because they have been filed in compliance with the Commission's Order and are designed to establish rates for the Emerald Pointe area upon the closing of the acquisition. Staff has no objections to the request for expedited treatment.
- 5. The Staff has verified that MAWC is current on the filing of its annual reports and assessments. Staff is not aware of any other matter before the Commission that affects or is affected by this filing.

WHEREFORE, Staff recommends that the compliance tariff sheets filed by Missouri-American Water Company on April 4, 2014, be approved by the Commission for services rendered on or after April 16, 2014:
