## **MAWC'S REPLY TO STAFF'S RESPONSE**

COMES NOW Missouri-American Water Company (MAWC or Company) and, in reply to Staff's Response filed on February 24, 2014, states as follows to the Missouri Public Service Commission (Commission):

- 1. On January 24, 2014, the Staff of the Commission (Staff) filed a recommendation to approve the Joint Application subject to a number of conditions (Staff's Recommendation). On February 6, 2014, MAWC filed a response to Staff's Recommendation, wherein MAWC agreed with all but one of Staff's proposed conditions (Staff Recommendation 5). MAWC's objection to Staff Recommendation 5 was based on Staff's failure to reference Section 393.320, RSMo.
- 2. On February 24, 2014, Staff filed a pleading entitled "Staff's Response," wherein it addressed Section 393.320, RSMo, as well as one other matter related to rate base.
- 3. As indicated by Staff's Response, while MAWC does not necessarily agree with Staff's legal analysis concerning Section 393.320, MAWC also does not object to the statement of consolidation recommended by Staff. MAWC further does not object to the rate base adjustment described by Staff's Response.

4. Accordingly, given the statement of consolidation contained in the Staff Response, MAWC has no objection to Staff's Recommendations as set forth in 1-16 (to now include Staff Recommendation 5), as reflected in Staff's Recommendation.

**WHEREFORE**, Missouri-American Water Company prays the Commission consider this Reply to Staff's Response and grant such relief as the Commission deems reasonable and just.
