ORDER APPROVING STIPULATION AND AGREEMENT AND APPROVING TARIFF

Issue Date: December 17, 2014

Effective Date: December 31, 2014

On November 26, 2014, Missouri-American Water Company (“MAWC”) and the Commission’s Staff filed a non-unanimous *Stipulation and Agreement* (“Agreement”). The Commission may resolve any part of this proceeding on the basis of a stipulation and agreement.¹ Since no party filed a timely objection to the Agreement, the Commission will treat the Agreement as a unanimous stipulation and agreement.² After reviewing the Agreement, the Commission independently finds and concludes that the Agreement is a reasonable resolution of the issues addressed by the Agreement and that such Agreement should be approved.

On December 3, 2014, MAWC filed a substitute tariff to comply with the terms of the Agreement. The substitute tariff sheet filed by MAWC under Tariff Tracking Number YW-2015-0090 bears an effective date of December 31, 2014. The Commission set a response deadline, and on December 5, 2014, the Commission’s Staff filed a

recommendation for the Commission to approve the tariff filing. No other party responded or opposed approval of the tariff. The Commission has reviewed the tariff filing and Staff's verified recommendation, and the Commission will approve the tariff sheet.

THE COMMISSION ORDERS THAT:

1. The *Stipulation and Agreement* filed on November 26, 2014, is approved as a resolution of the issues addressed in that *Stipulation and Agreement*. The signatory parties are ordered to comply with the terms of the *Stipulation and Agreement*. A copy of the *Stipulation and Agreement* is attached to this order and incorporated herein as if fully set forth.

2. The substitute tariff sheet filed on December 3, 2014 by Missouri-American Water Company, Tariff Tracking Number YW-2015-0090, bearing the effective date of December 31, 2014, is approved to become effective on December 31, 2014. .

3. Missouri-American Water Company's petition to change its infrastructure system replacement surcharge is in compliance with the requirements of Sections 393.1000 to 393.1006, RSMo.

4. Missouri-American Water Company is entitled to receive cumulative infrastructure system replacement surcharge revenues in the amount of \$25,637,873, including \$8,986,785 for this currently pending infrastructure system replacement surcharge petition.

5. This order shall be effective on December 31, 2014.
6. This matter may be closed on January 1, 2015.
