On January 10, 2017, Missouri-American Water Company and Audrain Public Water Supply District No. 1 filed a joint application for approval of a territorial agreement. Thereafter, the Commission ordered the Staff of the Missouri Public Service Commission (Staff) to investigate and file a report no later than February 21, 2017. On that date, Staff requested an extension of time in which to complete its investigation, indicating it was waiting for responses to data requests.

The controlling statute in this matter requires that the Commission rule on the application within 120 days of its filing, in this case May 11, 2017. Because there is sufficient time before the operation of law date, the Commission finds that the request for extension is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

 The Motion for Extension of Time Within Which to Complete Investigation filed by the Staff of the Missouri Public Service Commission on February 21, 2017 is granted.

- 2. The Staff of the Missouri Public Service Commission shall file its investigation report and any recommendations no later than March 17, 2017.
- 3. Any responses to the filing of Staff on March 17, 2017 shall be filed no later than March 27, 2017.
