DIRECTING STATUS REPORT**

The Commission issued its Report and Order Approving Territorial Agreement in this matter on April 6, 2017, becoming effective on May 6, 2017. The Commission issues this order to correct a typographical error in Ordered Paragraph 3. That paragraph directs Missouri-American Water Company to provide its “First Received Certificated Area Sheet.” The order should have said the “First Revised Certificated Area Sheet.” Therefore, the Commission will correct this error.

Additionally, that paragraph directed Missouri-American Water Company to submit a new tariff sheet within ten days of the effective date of the report and order, May 16, 2017. No revision has been filed in the case. Thus, the Commission will direct Missouri-American Water Company to file a status report regarding this filing.

THE COMMISSION ORDERS THAT:

1. Ordered Paragraph 3 of the Commission’s Report and Order Approving Territorial Agreement in this matter is corrected as set out above.

2. No later than June 5, 2017, Missouri-American Water Company shall provide a status report to the Commission with regard to the submission of new tariff sheets as directed in Ordered Paragraph 3 of the Report and Order Approving Territorial Agreement issued April 6, 2017.

3. This order shall be effective when issued.
